# AD. 3 – Realization of Work Plan of Sava Commission for FY 2017

## **3.1. Water management issues**

#### <u>Conclusions:</u>

- 1. The Sava Commission took note on the Status Report on realization of Work Plan of the Sava Commission for FY 2017 (Doc. No. 1R-48-O-18-2/1-3) with regard to water management issues.
- 2. The Sava Commission took note on the reports from the 34th and 35th PEG RBM Meeting (Docs. No. 3-17-6/3-2 and 3-17-16/3-2), and the 32nd PEG FP Meeting (Doc No. 3-17-13/3-2).
- 3. The Sava Commission considered and accepted the Interim overview of significant water management issues in the Sava River Basin (Doc. No. 1R-48-O-18-3/2-2).
- 4. The Sava Commission took note on the Status report on the Sava Flood Forecasting and Warning System (Sava FFWS) development (Doc No. 1R-48-O-18-3/3-2). With regard to the progress in the Sava FFWS establishment, the Sava Commission repeated its previous conclusion that is necessary that responsible institutions in countries, urgently, at latest in March 2018 enter into consultation process regarding the rights and obligations after the establishment of the System, given the provisions of the Article 9 of the Protocol.
- 5. The Sava Commission took note on the Status report on the development of the Flood Risk Management Plan for the Sava River Basin (Doc No. 1R-48-O-18-3/4-2).
- 6. The Sava Commission took note on the Status report of the development of the climate change adaptation strategy for the Sava river basin (Doc. No. 1R-48-O-18-3/5-2) along with the Outline of the Climate Adaptation Strategy for the Sava River Basin (Doc. No. 1R-48-O-18-3/6-2) and acknowledged support in the development of the Outline of the United Nations Economic Commission for Europe (UNECE), the Ministry of Ecological and Inclusive Transition (Republic of France) and the International Office for Water (IOWater).

# 3.2. Navigation issues

# <u>Conclusions:</u>

- 1. The Sava Commission took note on the Status Report on realization of Work Plan of the Sava Commission for FY 2017 (Doc. No: 1R-48-O-18-4/1-2) with regard to navigation issues.
- 2. The Sava Commission took note on the Report from the 20th PEG NAV Meeting (Doc No: 2-17-2/11-2-PEG NAV).
- 3. The Sava Commission considered and adopted Decision 1/18 on adoption of Marking and Maintenance Plan on the Sava River and its Navigable Tributaries for the year 2018. (Doc. No: 1R-48-D-18-1/1-2).
- 4. The Sava Commission considered and accepted Secretariat's expert opinion on navigation on inland waterways between Croatia and Slovenia and regulation of recreational navigation and use of the Kupa River in the border areas with a proposal of possible actions.

The Secretariat shall, with the assistance of the competent ministries and local authorities, identify common sectors on which navigation is taking place or there is interest to develop navigation and establish the basics for harmonization of the navigation regime.

The Secretariat shall develop the draft document regarding regulation of navigation on the identified common sectors and deliver it to the Sava Commission for consideration.

- 5. The Sava Commission took note on nomination of the members from Bosnia and Herzegovina of bilateral commission of Bosnia and Herzegovina and Croatia, for inland navigation, thus eliminating the need for the Secretariat to develop amendments to the related Sava Commission's rules in order to overcome the difficulties caused with temporary inactivity of the bilateral commission.
- 6. The Sava Commission took note on the Report from the 6th meeting of the Committee for monitoring and coordination of implementation of the project "Rehabilitation and development of transport and navigation on the Sava river waterway".

The Sava Commission tasks the Secretariat to address the relevant institutions in the countries and request all available data and event specific information related to floods occurred in 2009, 2010, and 2014 for the purpose of successful finalizing the Sava hydraulic model by the USACE experts.
- 5. The Sava Commission took note on the successful delivery and installation of IT equipment, purchased within the 2nd phase of the U.S. Government's support. The Sava Commission expresses appreciation to the U.S. Authorities for its support in acquiring the necessary IT equipment which will be among other purposes used for the operational functioning of Sava FFWS.
